TERMS AND CONDITIONS FOR FUNDRAISING EVENT SPONSORSHIPS

These Terms and Conditions govern your non-exclusive sponsorship of the event (the "Event") set forth on the attached sponsorship reservation form (the "Reservation Form") for the benefit of NYU Langone Health, comprised of NYU Langone Hospitals and New York University, for its Grossman School of Medicine and Long Island School of Medicine. Together with the Reservation Form, these Terms and Conditions constitute the agreement governing your sponsorship. Unless otherwise specifically noted, all references in these Terms and Conditions to paragraphs or sections will refer to the paragraphs and sections of these Terms and Conditions.

1. **Sponsors:** NYU Langone Health reserves the right to accept or refuse any Sponsorship in its sole discretion.

2. **Sponsorship:** In consideration of and conditioned upon the payment of the Sponsorship Fee, NYU Langone Health will acknowledge your Sponsorship as set forth on the Reservation Form. Sponsorships may include the Sponsor's logo and name; Sponsorships will not include any qualitative or comparative language, references to pricing, savings, or value information regarding Sponsor, its products, or its services. Sponsorships are non-transferable.

3. **Form of Sponsorship:** The Sponsorship will be in such form as NYU Langone Health determines in its sole discretion. Sponsor hereby grants NYU Langone Health a limited, royalty free, fully paid-up, non-exclusive, non-transferable, terminable right and privilege to use the name and logo specifically provided by Sponsor for the sole purpose of marketing the Event. 5. **Termination/Cancellation:** All requests for cancellation of a Sponsorship must be submitted in writing. NYU Langone Health may terminate this Sponsorship without cause upon written notice no less than 10 days prior to the Event or at any time in the event of material breach. In the event that the Event does not occur or NYU Langone Health terminates this Sponsorship without cause, NYU Langone Health will refund the Sponsorship fee amount to Sponsor within thirty (30) days of providing notification to Sponsor of termination of the Event or the termination. No refunds or credits will be issued in the event NYU Langone Health terminates the Sponsorship for material breach. In the event of termination for any reason, and wherever practicable, NYU Langone Health reserves the right to remove all references to Sponsor provided by the Sponsorship.

6. **Use of NYU Langone Health Name/Logo:** Sponsor shall not use the name, logo, symbol or marks of NYU Langone Health, including but not limited to New York University (or NYU), NYU Langone Hospitals, Grossman School of Medicine, Long Island School of Medicine, its faculties, facilities, or departments or any variations or combinations thereof or the name of any NYU personnel for any purpose without NYU Langone Health's prior written consent. NYU Langone Health's trademarks, service marks,

brand names, logos and artwork displayed on the signs and other materials used for the Event, and all trademark rights or copyrights in such signs and other materials, shall be and remain the sole and exclusive property of NYU Langone Health.

7. **Good Standing:** Sponsor represents and warrants that: (a) it is duly organized and validly existing in good standing under all applicable law and (b) it is not presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from participating in a covered transaction by any Federal department or agency.

8. **Force Majeure:** If for any reasons beyond its control, but not limited to, strikes, labor disputes, accidents, government requisitions, restrictions or regulations, fire, hurricane, earthquake, strike, war, insurrection, acts of war or acts of God ("Force Majeure"), NYU Langone Health is unable to perform its obligations hereunder and the Event is cancelled, such non-performance shall be excused and NYU Langone Health may terminate the Sponsorship Agreement without further liability of any nature.

9. **Indemnification; Limitation of Liability:** Sponsor shall indemnify and hold harmless NYU Langone Health, its related entities, trustees, officers, employees, and agents from and against any and all claims, losses, damages, judgments, settlements, costs, and expenses (including reasonable attorneys' fees) arising out of any act or omission of the Sponsor in connection with the Sponsorship, including any use of Sponsor's name or logo. OTHER THAN IN CONNECTION WITH A SPONSOR'S INDEMNIFICATION OBLIGATIONS, NEITHER PARTY WILL BE LIABLE TO THE OTHER FOR ANY INDIRECT, INCIDENTAL, CONSEQUENTIAL, EXEMPLARY, PUNITIVE, OR SPECIAL DAMAGES ARISING OUT OF THIS SPONSORSHIP AGREEMENT, EVEN IF SUCH PARTY HAS BEEN NOTIFIED OF THE POSSIBILITY OF SUCH DAMAGES.

10. **Governing Law:** This Sponsorship Agreement shall be governed by the laws of the State of New York, without regard to conflicts of laws.

Miscellaneous: All Sponsorship activities and promotions are subject to approval by NYU Langone Health. NYU Langone Health reserves the right to restrict, prohibit, or remove any activity, material, or promotion by Sponsor which, in its sole discretion, becomes objectionable for any reason and may detract from the Event or NYU Langone Health. In no event shall NYU Langone Health be liable for any expenses incurred as a result of such restriction, prohibition or removal. NYU Langone Health reserves the right to adopt additional guidelines and to modify these Terms and Conditions as may be deemed necessary by NYU Langone Health in its sole discretion, and such modifications shall be incorporated as if fully set forth herein.
